NOTIFICATION

In exercise of the powers conferred by section 15 of the Mines and Minerals (Regulation and Development) Act, 1957 (Central Act 67 of 1957), the Government of Karnataka, hereby makes the following rules further to amend the Karnataka Minor Mineral Concession Rules, 1994, namely:-

RULES

1. Title and commencement.- (1) These rules may be called the Karnataka Minor Mineral Concession (Second Amendment) Rules, 2020.

(2) They shall come into force from the date of their publication in the official Gazette.

2. Amendment of rule 32.- In rule 32 of the Karnataka Minor Mineral Concession Rules, 1994, (hereinafter referred to as the said rules),-

(i) in sub-rule (11), for the numbers and word "eighteen months from the date of commencement of these rules", the words "nine months from the date of commencement of the Karnataka Minor Mineral Concession (Second Amendment) Rules, 2020" shall be substituted;

(ii) in sub-rule (12),-

- (a) for the words "nine months from the date of commencement of these rules", the words "four months from the date of commencement of the Karnataka Minor Mineral Concession (Second Amendment) Rules, 2020" shall be substituted; and
- (b) after sub-rule (12), the following proviso shall be inserted, namely:-

"Provided that, if the holder of working permission fails to apply for conversion to quarry licence within the time limit specified under these rules rejected after consideration such working permission shall cease to be valid."

3. Amendment of rule 42.- In rule 42 of the said rules,-

(i) in sub-rule (5), for the words "thirty kilometer", the words "fifteen kilometer" shall be substituted; and

(ii) after sub-rule (5), the following proviso shall be inserted, namely:-

"Provided that, the validity of Computerized Mineral Dispatch Permit issued by ordinary sand lease-holder or licence-holder or his authorized person, shall be one hour for each thirty kilometer of distance or fraction thereof, from the date of issue."

4. Amendment of Schedule I-A.- In schedule I-A, to the said rules for the brackets, words and numbers, "(see clause (m) and (f) of rule 21)", the brackets, words and numbers, "(see clause (m) and (f) of rule 2)" shall be substituted.

5. Amendment of Schedule II.- In schedule II, to the said rules in the entries relating to serial number 33, in column (3) for words and figures "Rs.160 per MT", the words and numbers "Rs. 80 per MT" shall be substituted.

6. Amendment of Form GL.- In Form-GL of the said rules for the brackets, words and figures, "(see sub-rule (5) of rule 11, rule 27 and sub-rule (2) of rule 33)", the brackets, words and numbers, "(see rule 16)" shall be substituted.
